It supports over 4500 members, 160 member clubs, and it sanctions (and insures) over 500 events annually. We have a professionally staffed office open all year, 5 days/wk, 8 hr/day, which answers questions from members and provides on-site, technical, and administrative support for events. We administer these services in the states of MA, NH, RI and VT. In 2010 we directed National and Regional championship events and race series for our members.
