

**USATF - NEW ENGLAND ASSOCIATION
ANNUAL MEETING
September 15, 1997**

Venue: Wellesley College Athletic Center, Wellesley, Massachusetts.

President, Ron Boemker, called the meeting to order at 7:15 pm., welcoming all those in attendance. Ron's opening statement included the following:

1. Acknowledgement of Ed Sheehan's leaving the Association and the Boston area and thanked him for his positive efforts on behalf of the running community.
2. Explanation that the Boston Marathon will no longer require USATF membership and thanked the B.A.A. for all its efforts in behalf of USATF and that the two organizations will continue to work together on future planning and events for New England athletes.
3. Goal for new Board will be a thorough review and revision of the existing ByLaws.
4. Establish set of reasonable Title IX implementation guidelines for race directors and athletes.

Ron commended Steve Vaitones on his good work and tremendous efforts for and on behalf of the Association and commended the overall organization on a productive year.

A Quorum was established at 7:40 PM for the purpose of electing sports chairs, athletes representatives and Convention delegates.

Annual Reports were submitted by the Office Staff, Treasurer, Sports Chairs, and Athlete Reps. and available for everyone present. Brief oral reports followed.

Annual Election of Sport Chairs and Athlete Reps: Ron Boemker emphasized that sports chairs and athletes reps need to attend monthly Board meetings, volunteer at Association events, and help with office details. He explained the voting procedures and rules regarding voter eligibility.

Incumbents were polled to determine who was running for re-election. Nominations were taken from the floor and each candidate gave a brief (2 minute) presentation. A question and answer period followed, and elections of new officers and sport chairs took place.


New Business:
