AWARDS - Limited to USATF-New England Individual and Club members

INDIVIDUALS

Championship Medals - Top 3 Open, top 3 Masters in 10 year divisions

Individual Open Prize Money - Sponsored by the Boston Athletic Association

Open: 1st - \$200 2nd - \$150 3rd - \$100 4th - \$75 5th - \$50 6th - \$25

Champions are eligible for \$300 travel reimbursement to USA Nationals

Top eligible Open NE runners may be eligible for a trip to Ireland's Ras na hEireann

Masters Prize Money: First place in each 10 year division in masters race - \$50

TEAM PRIZE MONEY:

Open Team: 1st place \$200 2nd place - \$150; 3rd place - \$125; 4th place - \$100
40-and-over Team: 1st place - \$ 150 2nd place - \$100 3rd place - \$75
50-and-over Team: 1st place - \$ 100 2nd place - \$75
60-and-over Team, 70-and-over Team: 1st place - \$ 50

COURSES – Standard Stanley Park courses will be used. Maps at website
Courses are a mix of fields and trails with some exposed roots and rocks.

No dogs are allowed on the course or in the race area.
