#### ENTRY INFORMATION

Region I Entry Fees: \$5.00 per athlete per individual event entered. Decathlon & Heptathlon \$10. Relays \$10 per team. Association Youth Chairmen must forward all final entry forms, a single check (from the association) or a money order made payable to USATF-New England, a copy or disk of the complete results of the association meet - all to be received no later than June 24, 2003 - to USATF-New England, 2001 Beacon Street, Suite 207, Brighton, MA 02135. No entries accepted after June 24.

## ELIGIBILITY and WAIVERS

Participation is limited to US citizens, resident aliens, and foreign exchange students.

**USATF** rules apply unless superseded by the Youth Athletics Handbook.

With approval of the youth athletics chairman (See USATF Rule 245), athletes who miss the Association Meet because of extraordinary circumstances may be allowed to advance to the Region I meet **if this does not displace** athletes who competed at the Association Meet. Associations are limited to six athletes/relay per event. Contact the home association for waivers. All waivers must be submitted with an association's entry.

### **RELAYS**

Relay teams consist of four athletes and alternates. After a team is entered at the association meet, NO additional athletes may be added or used. All team members MUST wear the SAME color top and bottoms (tops and bottoms do not need to match each other). Team members MUST be of the same age division. Teams must be declared 30 minutes before their race.

#### **RESULTS**

Results will be posted near the track, and will also be posted at www.usatfne.org and www.usatf.org

#### **AWARDS**

Gold, silver, and bronze medals will be awarded to first, second, and third place in individual and relay events.

The fee is returnable if the decision is reversed.

Note that the hammer is an exhibition event - athletes do not advance to the nationals. In the combined events, the top two advance to nationals and a third only if they meet the performance standard for the event. ALL ENTRIES MUST BE SUBMITTED AT THE REGION I MEET!

Athletes competing in the USA Junior National Championships may advance directly to the National JO meet, but this waiver must be completed prior to the Region I meet.
