1) Have thrown the weight in a competition this season (allows unlimited entrants from same school)

Or, 2) Statement from coach that the individual has practiced and has been coached in the event (max 2 per school in this category)

**ORDER OF EVENTS**

**All throwers should check in by 12:00 noon**

**12:30 p.m. GIRLS' 20# weight throw**

**Followed by BOYS' 25# weight throw**

**COMPETITION: Three throws, top eight throwers advance to finals for three additional throws**

**AWARDS: Medals to top six places in each division, Winners' names on permanent plaque, Additional awards**

**ENTRY PROCEDURE: Pre-entry preferred, to arrive by Monday February 20.** Checks payable to USATF-New England
